My comment on Item 3, the Henrietta connection went into effect to the new sewer plant today, so the South pump station is operational. The oxidation ditch will probably be cut over tomorrow or the next day. On Item 4, we received a letter from the three representatives from MDNR, they didn't find any problems, outlined their visit, their jurisdiction regards wastewater regulations and everything looks to be in accordance to the plan and going well. Councilman Dunwoodie asked

C/A stated that we need a Public Works Committee meeting is discussed numbers. Councilor Guy passed on the comment received from citizens regarding how nice it looks with the old houses is coming down especially the one by the Fire Department.

Bond said for clarification purposes in the paper I noticed for the Richmond Early Childhood Facility it says that the estimated CDBG funds was \$998,160 which was the grant and then it talks about the total cost of the project is \$1,131,061 and there is a difference there of about \$130-\$140K, who pays the difference or is there a difference. Mayor stated it's not the City of Richmond. C/A stated whatever it is on them not the City. Councilman Bond said the second question is it states about boring a water line, which I assume since it's outside the city limits, which will pay for that. C/A stated they will. We provide water to them now, there is a fire hydrant by the creek, and they will tap into that. Councilor Bond said they will do that and we will not be out any money. Mayor and C/A stated correct they will put a 2" line in to service their facility. Bond stated since the City is merely a pass through, in the FY15 budget the line item Early Childhood Dev Expense has \$20,000, I think the night it was handed out was \$42,000 where is that money, I mean who draws down the money, does the City of Richmond as necessary. Rebecca Hoeflicker, Finance Director explained the process. Molly McGovern is the Grant Administrator. She requests the money after reviewing the invoices and submits a Request for Funds from CDBG, which is forwarded to us. CDBG sends to the money to us and we forward (money) it to MVRCC for them to pay the invoice. It's a pass through. Councilor Bond said, again, the City of Richmond is not out any money and who is going to do their payroll. C/A stated whoever does their payroll now, we are not responsible.

Recall our primary purpose was to incorporate several payers and increase base rates for large users such that we could reduce the base charge for the maximum number of people. This resulted in a rate of \$15.25 which generated annual revenues of \$600,000 which resulted in a cushion of about \$30,000 per year beyond that required to meet our bond payments. During the discussion, council determined paying bonds early was a priority. I respectfully ask council to reconsider and allow staff to use \$16.00 as the base charge for wastewater rates. We would have to establish rates at \$16.85 per month which is only a \$3.24 monthly savings. We would be accumulating money in an account that only earns 1/4 of one percent interest. There is approximately 350-400 residents that do not pay a base rate. I urge Council to allow staff to work with a figure that allows maximum reduction to the majority of rate payers. Discussion by council. Motion to accept Plan A with a possibly of making it \$16.00 or a rate that will generate approximately what we are generating now, I move we go with Plan A by Guy, second Kinnard. Mayor commented the Mushroom Festival went very well, no major issues. The first of the month, I attended as a guest of State Rep. McGaugh the Clay County Lincoln Days, and the Missouri House Speaker was the guest speaker. Very informative.

CITY ADMINISTRATOR – Ron Brohammer – report included in the packet. C/A agreed with the Mayor about the Mushroom Festival. The police did a great job. Terry Dickey from Parks was in charge of maintenance and clean up and he was superb. Tonya was keeping track of all their money. In my opinion, was one of the best. I attended the City Managers/Administrators Association conference last week, Wed, Thurs., Fri at the Lake of the Ozarks, it was very successful. Had some great discussions and speakers. Troy Nash and Chris Williams will present a Work session on different incentives for Economic Development on May 26 from 4-6, just prior to the Council Meeting. We have invited the Steering Committee and others. Open House May 30, 9-1 for the WWTP. As you see we lost a people office and will replace with a reserve officer. We will be receiving a NOV from MDNR for silk fencing not being maintained.

UNFINISHED BUSINESS:

Wastewater Rates – C/A stated he is still unsure where the Council wants to go with adjusting the base rate. At the last council meeting three options were offered. Staff has done some calculations and we think that our basic plan is what we would like to move forward with essentially what we talked about the last council meeting. We would recommend considering raising that base rate to \$16.00 vs. the \$15.25 that we talked about. Raising it to \$16.00 will generate an additional roughly \$60,000 a year. Now, you can't adjust any of the bonds until 2022 about seven years away. We could pay off the USDA bonds anytime but at interest rate of 2.75% I would touch those. We could create a sinking fund and in seven years pay down then continue however council at time chose to do that. I just need guidance to move forward. What we are proposing to move forward is a public hearing at the last council meeting in June and I can't hold a public hearing if I don't know what you want.

Councilman Powell said we voted on Plan A at the last council meeting. C/A state you did but added an adjustable rate at a different rate level. Councilwoman Guy stated the motion was, but, added to make it would be what we were making now. I am quite willing to withdraw that and you can go back to \$15.25 if you want to. Back to the original motion. Do you and Rebecca feel that the \$16.00 is, are you doing that to make extra to pay off the bonds?

C/A stated, I think that is reasonable and would give every one of the current rate payers a \$4.00 savings and of course, if we pick up the extra rate payers, that we have talked about, that would pick them up. This all centers around picking up rate payers that are not paying a base rate. Not to pick on, the multiplex right off of Royle and Camden. It has eight gas meters on it, 8 electric meters and one water meter. Now, that's my whole point.

Councilman Dunwoodie asked, does it use 5000 gallons a month? Marilyn said it uses about 10,000 – 15,000 gallons a month. C/A stated the point is to get a base rate that is equable for everybody that is a user. Not necessarily a volume consumption although that does play into it, as we have talked about, as base equivalent units for larger users. Dunwoodie further stated a larger user is going to pay a larger impact fee when they hook on, they will pay more for sewer because what goes through the water meter and multiplier to come up with what their sewer rate is. C/A is yes. Marilyn said \$7.98 a 1000 gallons. C/A said that is the usage fee when is different from the base fee. The base fee we have tried to establish the fee for the bonds to make the "mortgage payment" for the plant and a larger user causes you to create a larger plant. Individual users cause you to create a bigger plant because you have to be able to process it. This is all this is about; there is no magic or mirrors here. If you don't want to do it, we can leave it at \$20.09 and go on down the road. Dunwoodie stated we have gone to the people twice on bonds and told them this is what is going to be. C/A state true, but, now we have the opportunity to give back.

Dunwoodie stated, you (C/A) told us we had to have \$20.09 to pay the bonds. C/A stated that is correct, but, if you don't want to collect from all that are not paying a base charge, then don't. But, you have the opportunity to lower the base rate for everyone by collecting from those that do not pay the base charge. The base rate pays the mortgage and the usage fee pays the utilities, salaries, equipment, etc. Dunwoodie stated, one of these days, if we keep changing everything, they won't vote for nothing. C/A said even though you told them they would pay \$20, but, would only have to pay \$16 now, don't you think they would appreciate that.

Mayor stated after \$15.25 to \$16.00 at seven years there should be a big chuck of money to pay down on the bonds. Then after that first seven years you can also pay more if you have money.

Council Powell stated, I am confused by the \$16.85 per month. C/A stated, Deanna made a motion at the last meeting that we establish the rate at an amount that would generate the same amount of dollars as the \$20.09 does and incorporating the other users. That is what this is all about incorporating the other users. Councilor Powell said, "I like that \$15.25 figure, but .75 doesn't make a difference, I guess." C/A said I was trying to reach a comprise that was agreeable to everyone that would generate a little extra money that you could develop a sinking fund and in seven years and generating the interest which will be small because we get a very small amount in interest, but would have \$375,000 that you could apply to the front of the loan, but, you do anything to commercial bonds until 2022, when their first call date comes up.

Further discussion on how fast loan could be paid off, this change is not set in stone the rate is always up to the council with a public hearing. C/A state I am only looking for direction on what number (rate) you want to use for the public hearing or if you want to do this or not. I need one direction and two a number.

Councilor Peterson said he received many calls regarding from his constituents regarding not to make the change. I tried to explain the benefits. Councilor Williams, stated he thought it was the right thing to do, and I don't know, it will cost landlords more money, but I would like to give back to the citizens. Councilor Powell will this make new multiplex have all the meters; I think we should give back to the citizens.

Mayor asked Chris Williams what we should do now. Chris stated we are just looking for direction on the amount for the public hearing and for the ordinance. We just need to know how to do the ordinance.

You can do it by consensus. Mayor said we will go with the rate of \$15.25 and prepare for the public hearing.

C/A when we get to the public hearing, June 23, that the council has proposed \$15.25 incorporating mutli users, you all know what we are proposing. That is not the time for the council to disagree with what you said now. It's a public hearing and for the public. I want direction of the council. Mayor said the consensus is \$15.25 and work on the public hearing.

WELCOMING REMARKS – Mayor Wright welcomed everyone to the meeting.

PUBLIC HEARING - Mayor opened the public hearing regarding sewer rates at 06:32 p.m.; Ron will give the presentation and after that will be time for comments.

Ron Brohammer - Good evening, this public hearing is for the purpose of considering an adjustment to the base sewer rate for the City of Richmond. In 2009 the City of Richmond was based with a critical issue. It operated two wastewater treatment plants one at the north end of the city and one at the south end. MDNR was dictating effluent discharged from the North Plant would have to be disinfected or have disinfection treatment or the plant would not be allowed to continue operation after 2011. Additionally, the south plant has a seriously damaged oxidation ditch and was very near failure and beyond repair. Compounding these two issues and MDNR directive that no additional services would be allowed at the south plant as it was operating near its design capacity. Clearly has these three issues came together, major steps were required. It was determined with the bond issue of \$5.1M and grants of \$4.7m that disinfection at the north plant and an extension at the south plant. In 2010, the voters approve a \$5.1M bond issue but the anticipated grants of \$4.7m did not materialize. Subsequently in April 2011, voters were asked for an additional \$4.1M in bonding authority which they approved by a significant margin. The new plan for closing the north plant entirely and completing a new plant south and a pump station at the north plant and that would pump everything from the north side of town to the south plant. Richmond citizens were told that based on the number of connections, sewer base rates would be \$20.09 for connection. We also hoped at that time usage fees could be cut by approximately .50 cent for 1000 gallons per usage. That however is not going to happen. Five years has passed since that projection. Electricity, equipment, salaries have all increased since that assessment. We cannot lower the usage rates but, we can lower the base rate. One might think of the base rate, just like a mortgage. Our bonds for the new plant cost are approximately \$600,000 a year. The base rate was established to meet the requirements with a number or connections and current billing structure requires \$20.09 per connection. As we looked at the current system of calculating the base charges two things became apparent. One, we have several multiple family living units that have one and only service connection and they are paying on one base charge. We have complexes with 2, 4, 8 or more families but only paying one base charge to the city. These seem unfair to call the single family units that are also only paying one base charge. The second thing we noticed was commercial activities were only paying only one base charge, yet, they used

many more times the plant treatment capacity than residential users. In fact, the largest users in Richmond are in the south part of the city service by the south plant. Shirkey Nursing and Care Facility our largest user, Walmart, 3 car washes, the hospital and dialysis center all these are significant contributors to the south plant in reaching its capacity. If we had not built the new plant, several new businesses would have not been able to locate in the south area. Including, the new Swafford Ford location, relocation of C&C Drug, the dialysis center and ultimately whoever develops on the property just north of McDonalds. The fact of the matter is commercial activity was a direct contributor to requirement to build a new plant. In addressing these two concerns, staff has proposed to the City Council that all multi-family residents be assessed a base charge for each occupied living unit; if the units are not served by an individual water meter. Commercial units would be accessed a base charge base on each 15,000 gallons used or partial amount of 15,000. These will be referred to as BEUs or Base Equivalent Units. We determined this number based on usage of some of our largest residential users even though the average residential user is about 5,000 gallons per month. Using this method, the base charge will be reduced for all from \$20.09 to \$15.25. We believe this is both reasonable and equitable for all users. Now just to be clear, there is nothing magic here, we are simply adjusting our billing or proposing to adjust our billing, so that as many as possible are equitably sharing in the cost plant construction. Specifically, we not have 2175 single residential users, when we pick up the additional users that are the additional mulit family users not paying a base charge we add 435 users. So there are 435 individual family units that are not paying the base charge. This brings the total single residential user up to 4610. As for commercial users we presently have 201 single base rate charges. But when we calculate their base charge using the BEU of 15,000 gallons we add 110. Bring that equivalent base charge to 311 users. By using these counts we have a total of 545 equivalent users which allows us to bring the base charge down for everyone to \$15.25 versus \$20.09. Mr. Mayor.

Staff and I met with Peter Hinkle from Schneider Electric their purpose is to try and help municipalities save money on different utilities and such. The survey is free and we are putting together some information for them to look through and provide back information to us regarding potential savings. I would also like to point out item number two under other hydrants the marketing branding and communications working group is seeking ways to develop a new city seal/logo currently it is a anchor and a rope. The chairman is Councilor Deanna Guy.

A. Completion of Pigging Project. Councilor Peterson stated as discussed in the committee meeting earlier, about completing the pigging project met with Mr. Decker and he has an excellent plan to move forward and the committee feels not only an necessity the cost has been high due to all the residue in the lines. No one could have anticipated the amount of residue in the lines and we feel that this project needs to be completed. Motion to approve the completion of the pigging project not to exceed the estimate of \$29,000 by Peterson, second Williams AYES: Williams, Peterson, Coleman, Kinnard, Persell and Guy. NAYS: None. - C. Paving of Alleyway behind Ray County 911/Hometown. Councilor Peterson stated we needed to bring this to the council as a whole. This is an ongoing issue that we have discussed before, yet we have a policy that we don't touch alleys. There should be a discussion, as a council, as to whether we want to do something about addressing commercial alleys vs. residential alleys. On one hand, we are trying to develop business up at the square with redevelopment, this is the alley behind 911. It would be great to do that, but, do we really want to set a precedent of taking on the task to maintain residential alleys—can we separate and what can we do? What is the council's preference? At one time we had talked about the County participating on the paving of the alley, and that has since gone south.

Councilor Guy asked if the committee had a recommendation? Councilor Peterson stated there was only two members there tonight and one has an interest. So, no, that's why we decided to bring it to the full council.

Persell asked, has the alley ever been paved? Williams answered yes. Williams stated that the county and the city did partner and concreted the entrance way behind 911. Also in 2008, it did have blacktop on it and in 2009 or 2010 the city dug it up to replace the water line. They put gravel on it and it has washed out ever since. There are seven different businesses that use that alleyway. Persell asked what did the City do behind Jones Store? Mayor stated that was a storm water project. Persell asked what did the City do to the street? C/A stated only put roto mill on it. I have discussed this with the County Commissioners and asked if they would pay for the work or would partner the project and discussed that notation with some of the business owners and the Commissioners said they were not interested in participating. Williams stated the alley does not belong to the business owners and the County has a parking lot on the other side of the alley back there.

City Attorney Chris Williams, stated the City has right of way for an alley and I never hear anyone discuss alleys, so I really don't know who is responsible. Most of the time, if it ever comes up, its when someone wants to vacate an alley because it's not used. Williams said, yes, but you have to get

City approval to vacate. Persell asked how hard would it be to distinguish the difference between a commercial alleyway and a residential alley way? Peterson stated is should be a fairly easy straight forward assessment depending on the mapping system. It should be a fairly easy process. I think that is a reasonable request. Guy asked how much is the cost for the alleyway \$4500?

C/A said that is with Metro Asphalt and determining the difference between commercial vs. residential, it's pretty clear. They are either in the commercial part of town or the residential part. There are commercial alleys that are not used or are not used much and then are you going to address them as they come or if someone request it? As I said last week, this is a policy that the city has maintained for years. To me, a residential and commercial is obvious, but to go and inventory them; what about the alley behind the old Walmart Store is that an alley? Williams stated they own that property. Persell stated I don't want to set a precedent, but, I want make sure we can justify what we are doing. Guy asked who all drives or parks back there (alleyway). Williams stated all employees and if there is a store front they use that alley. Guy stated, I don't know if how the citizens would look upon paving an alleyway vs. a street. Williams asked how much money was spent on that at Hubbell/McCart that was widened for one business for a truck entrance that is never used.

Councilor Peterson stated that I do see both sides of this, that we don't want trucks sitting out front of the businesses blocking traffic and the other side of that is you do one, then they all want it. That is why I like Mike's (Persell) idea how we could determine and how it would affect us. I don't want to see delivery trucks blocking the square. I am disappointed we are not getting assistance from the County. Further discussion regarding - who is responsible and what is the policy.

Persell further stated, isn't it our policy if we did indeed tear up the alleyway then it is our responsibility to fix it. We do not have to get into the discussion if we maintain alleys, we are simply replacing what we tore up. Mayor said so just do the strip that we tore up? After a lengthy discussion, Councilor Persell made a motion to replace the pavement portion of alleyway back to its original condition. Motion rescinded later.

Mayor stated that's not really getting us where we need to be. That is more of a public works policy, I would think. The question is whether we are going to asphalt this alley or not asphalt it. Persell stated I can't say I want to asphalt the whole alley. Peterson said if our actions caused this. Dale Shipp stated what it would take the asphalt the alley.

Councilor Williams stated, he would talk to the business owners about partnering on the alleyway and at the next council meeting we can decide. After further discussion, motion to have 50% participation for an asphalt project, City to spend \$2250 and other seven business owners or buildings to fund the rest of the 13 x 311' alleyway by Councilor Guy, second by Councilor Persell.
